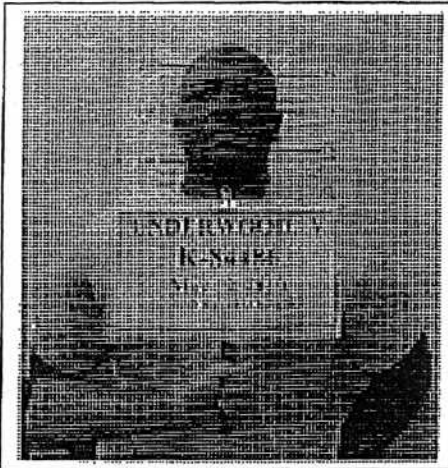

#### ADDITIONAL INFORMATION

##### STAFF ASSAULTS:

11/21/2006-Underwood became verbally abusive with staff and punched a Correctional Officer in the face.

##### SECURITY PRECAUTIONS:

Central file reflects one escape attempt from county jail, however specific circumstances are not noted. Central file also notes Underwood was suspected in multiple sex offenses on the East Coast prior to his incarceration in California, without successful prosecution.

##### DISCIPLINARY OFFENCES INCLUDE:

1/22/2009- Threatening cellmate

11/21/2006-Battery on a Peace Officer (see above)

9/22/2005- Disrespect (plus four additional violations for the same offense)

##### NOTES:

Underwood claims to be a devout Sunni Muslim. Documentation indicates he has utilized Muslim Chapel to radicalize Muslims on the General Population (GP). While on the GP at a different institution, Underwood had significant influence over the entire Black inmate population to include Muslims, Bloods and Crips. It appears Underwood may have also taken part in a plot to murder the Muslim Chaplain.

Underwood claims to have a BA degree in Psychology and his central file indicates he may have been dishonorably discharged from the United States Marine Corp. He has five siblings; two of which are employed in Government Service. His sister [REDACTED] is listed as an employee of the Secret Service in Washington DC and his sister [REDACTED] is listed as an administrator for the Department of Veterans Affairs in Washington DC.
