



Constitutional violations and forms of harrasment at several correctional institutions. Months after being housed at ECCF I became aware of a document supplied by PBSP officials that have incorrect, fabricated info. that PBSP officials knew would subject me to hostilities. This document incorrectly states 1. That I am a Piru Blood. 2. That I have a prior escape attempt. 3. I have radicalized Muslims in general pop.. 4. I have influence over the entire Black inmate population (Crips & Bloods). 5. I took part in a plot to murder a Muslim Chaplain. 6. I have a dishonorable discharge from the U.S.M.C. 7. My sister [redacted] is employed at the Secret Service in Wash. D.C. 8. My sister [redacted] Underwood works for the Dept. of Vet. Affairs in D.C. PBSP officials conduct was motivated by evil motives or intent and demonstrated a reckless or callous indifference to my State & Federal protected rights that resulted in violations of my First, Fourteenth & Eighth Amendment rights under the Constitution of the United States.
